- ・一定の要件のマイホームの取得などで住宅ローンがある

- * 還付金を受け取る口座の通 帳 (申告者名義)
- ・マイナンバーカード
 - *マイナンバーカードがない場合は、マイナンバーがわかる書類(通知カードや住民票の写し)

 「はんにんかくにん なく 古人 在認ができる書類(在留カード、運転のなきによう 免許証など)
- ・扶養している人のマイナンバーがわかるもの

Kanpu-shinkoku

In regard to your income tax, if the amount of money withheld is greater than your calculated tax due, the difference will be refunded to you only if you file your final return. This is called "Kanpu-shinkoku" (a return for refund). You can do Kanpu-shinkoku retroactively, for returns up to 5 years prior.

You may file to receive refunds if any of the following circumstances apply:

- You quit your job in 2023 and didn't have a year-end adjustment (for employment income earners);
- You have additional tax deductions (a social insurance premium deduction, life insurance premium deduction, etc.);
- You paid a medical bill that exceeds a certain amount; or
- You bought a house which satisfies the designated requirements, and you applied for a housing loan.

To file your return, you will need the following items:

- Original withholding slip for employment income or public pensions
- Bankbook (in the name of the applicant) to receive the refund
- My-Number Card
- * If you do not have the My-Number Card, your My-Number Notice Card or a copy of your Certificate of Residence, and your ID (Residence Card or driving license)
- Your dependents' My Number
- Certificates for various deductions (a certificate for life insurance deduction,

a certificate for medical expenses deduction, etc.)

For the other documents needed, please check with the Ageo Tax Office.

To enter the venue, an entrance ticket is needed. Tickets will be distributed on the site on each day. Registration will be closed as soon as all tickets for the day have been distributed. They can also be obtained at the official Line account of the Tax Agency in advance.

The final tax return cannot be filed if any of the required documents is missing. Therefore, please confirm what documents are required for your filing with the Tax Agency's website in advance. You can also file from home using your smart phone or your computer, without coming to the venue for filing. If you use your My-Number Card for on-line filing, your password (4-digit numbers and 6~16-digit alphanumeric characters) will be needed.

Filing Resident Tax Returns

Resident tax returns will be accepted for filing from February 16 (Fri) through March 15 (Fri). At the end of January, resident tax return forms will be sent out to those who filed a resident tax return in the previous fiscal year. Forms are available at Shiminzei-ka (2F of City Hall) and City Hall branch offices. They can be downloaded from the Ageo City website as well. You can file a resident tax return by sending the filing to Shiminzei-ka by post, by dropping it at the acceptance box located at Shiminzei-ka, or filing a return at the office which will be temporarily set up for each area. If you file a final tax return, you don't need to file the resident tax return in principle.

National Pension

All residents of Japan, regardless of nationality, are required to join the National Pension System (Type 1 insured) when they turn 20 years old, with the exception of company employees, public servants and their dependent spouses. You don't need to go through any procedures to join the National Pension System. Within approximately two weeks of your 20th birthday, the Japan Pension Service will send you contribution





To Use Bicycles Safely

Since bicycles are "light vehicles" under the Road Traffic Law, they are subject to various regulations. When riding a bicycle, please follow traffic laws and rules, observe manners and ride safely.

Follow Traffic Rules

- O Five Rules for Bicycle Safety
- 1. Ride on the street, in principle, and on its left side. Riding on the sidewalk is exceptional, and pedestrians are given priority

However, the following individuals may ride bicycles on the sidewalk: children under age of 13, people aged 70 or older and people with physical disabilities. Cyclists are also allowed to ride on the sidewalk when road signs indicate "exclusively for cyclists and pedestrians" or when there are compelling reasons. On the sidewalk, cyclists must travel slowly so that they can stop immediately, and must stop to move out of pedestrian's way.

Obey traffic signals, stop and look both ways at intersections to check safety



- 3. Use a light at night.
- 4. Do not ride when under the influence of alcohol
 Just like driving a car, you must not ride a
 bicycle under the influence of alcohol. Also, you
 must not provide the bicycle to someone who is
 under the influence of alcohol or offer alcohol to
 someone who is likely to ride when drunk.

- You are obliged to be covered by bicycle liability insurance when riding a bicycle in Saitama

Leaving Bicycles Unattended is Prohibited

Ageo City pastes a warning sticker on bicycles left unattended in the area near Ageo Starion where leaving bicycles unattended is prohibited. If the bicycle is still there after 3 hours of pasting the sticker, it will be removed. Please park your bicycle at a parking lot. Your understanding and cooperation are appreciated.

Be Sure to Lock Your Bicycle

In addition to the original lock attached to your bicycle, double lock the bicycle using a wire lock. By connecting your bicycle to the solid object with the wire lock, it will be less likely to be stolen.
